Our voluntary MAP Alert email service provides reminders about the more than 40 endorsed insurance, financial, legal, and shopping/travel/personal programs available to NYSUT members. This service is a great way to learn about these programs and become acquainted with Member Benefits!

MAP Alert messages are sent approximately once every three weeks. A MAP Alert may be an advance notice of a change in an existing plan, advance notice of a new endorsement or simply a reminder about a program. We also offer a number of special drawings throughout the year available exclusively to MAP members.

## NYSUT Member Benefits New Member Welcome Program

As a new NYSUT member, you will receive a special welcome mailing from NYSUT Member Benefits upon our receipt of new member enrollment information from your local association. The mailing will be sent to your home address and include:



- Information about the many endorsed **Shopping/Travel/Personal programs** in place for NYSUT members.
- Provision of a no-cost **Term Life Insurance policy providing coverage for up to \$25,000\*** for one year, as long as NYSUT membership is maintained through your local. New members under age 40 will not need to complete any paperwork to receive this no-cost coverage.

New members age 40 and older will receive the no-cost coverage for a one-year period if they can successfully answer several medical questions as part of a simplified issue offer. The insurance is guaranteed renewable for up to \$25,000 at the end of the year with no additional medical underwriting.

- The NYSUT Member Benefits Trust-endorsed **Disability Insurance Plan\*\*** can provide vital income replacement at a time when you need it most. As a new member age 64 or younger working 20 hours per week or more, for a limited time period you have the opportunity to apply for a long-term monthly disability benefit with just a few health-related questions.

*\*There is no obligation for you to renew the policy at the end of the free year. (Please note that there is no term life insurance benefit provided to new members age 85 or older.)*

*\*\*Contact the plan underwriter, Unimerica, at 800-515-2471 for more details and information concerning the benefit limits that apply to this offer.*

For purposes of these offers, a new member is considered to be anyone -- including an agency fee payer -- who has never been a member of or agency fee payer to NYSUT in the past. Transfers from one local association to another will not be considered new members.
