

SUMMARY ANNUAL REPORT
FOR NEW YORK STATE UNITED TEACHERS MEMBER BENEFITS TRUST

This is a summary of the annual report of the New York State United Teachers Member Benefits Trust, EIN 22-2480854, Plan No. 503 for the period September 1, 2024 through August 31, 2025. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the New York State United Teachers Member Benefits Trust has committed itself to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with various insurance companies to pay certain claims incurred under the terms of the plan. The total premiums paid for the plan year ending August 31, 2025 were \$67,033,284.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending August 31, 2025, the premiums paid under such "experience-rated" contracts were \$48,218,723 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$23,062,454.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$69,468,366 as of August 31, 2025, compared to \$64,173,744 as of September 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$5,294,622. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$19,014,169, including participant contributions of \$3,882,855, realized loss of (\$271,191) from the sale of assets, earnings from investments of \$6,107,282, and other income of \$9,295,223. Plan expenses were \$13,719,547. These expenses included \$10,337,042 in administrative expenses and \$3,382,505 in benefits paid to participants and beneficiaries.

5. Information regarding any common or collective trusts, pooled separate accounts, master trusts, or 103-12 investment entities in which the plan participates.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

Paperwork Reduction Act Statement
