New: Premium Calm Service Member Benefits is pleased to offer the premium Calm subscription as a free benefit for all NYSUT in-service and retiree members. The premium Calm

subscription provides members with unlimited access to the full library of content at *calm.com* and in the Calm app, which can be utilized via a desktop, laptop, tablet, or mobile device (iOS or Android). Members can add up to five dependents (age 16 or older) to receive their own premium Calm subscription. Dependents can only be added through the *calm.com* site (not the Calm app).

Explore guided meditations and specialized music playlists to help with stress and focus, mindful movement video and audio, relaxing sleep stories, nature scenes and sounds, specific content tailored for children, master classes led by experts, and more.



Peer Support Line

The Peer Support Line, created in partnership with Rutgers University Behavioral Health Care, is a confidential helpline provided at no cost to all NYSUT

members and their families. Staffed by trained in-service and retired individuals who understand the unique professional and personal challenges of NYSUT members, the Peer Support Line can provide answers, resources and empathetic support when it is needed most. Student Loan & Credit Counseling

Our endorsed student loan and credit consolidation program with Cambridge Credit Counseling can assist NYSUT members and their family members with better understanding their student loan repayment and credit/ debt resolution options.

Accidental Death & Dismemberment Insurance

All NYSUT members (both in-service and retiree) are automatically provided with a \$5,000 accidental death & dismemberment insurance benefit.

Travel Assistance Services

All NYSUT members (both in-service and retiree) are automatically provided with travel assistance services from AXA Assistance that focus on providing coordination services to travelers.

Financial Counseling Program

Our endorsed Financial Counseling Program offers unbiased, objective advice customized to your specific financial needs. For an annual fee, participants receive up to six hours of virtual or toll-free phone consultations with a Certified Financial Planner. A 403(b) Advisor option is also available for a reduced annual fee that limits advice to your 403(b) retirement savings plan.

Legal Service Plan

For an annual fee, our endorsed Legal Service Plan provides expert guidance for personal legal matters, as well as a Simple Will, Health Care Proxy, Living Will and Power of Attorney at no extra charge; other plan features include guaranteed maximum fees and a network of referral attorneys.

Life Insurance

Retiree members are eligible to participate in several of our endorsed life insurance plans that provide important financial protection for your family in the event of your death. You may no longer be covered by an employer plan, so it's important to look into this crucial benefit.

Convenience & Savings with Pension Deduction

Enjoy the convenience, elimination of service fees, and up to a 15 percent discount when you use pension deduction as your payment method for Member Benefits-endorsed programs. Premiums are divided into even amounts and automatically deducted from pension benefits. If you are recently retired and were paying for benefits through payroll deduction, you must contact Member Benefits at 800-626-8101 to begin the process of converting to pension deduction.
