Whether you're a nurse or health care worker, bus driver, teaching assistant, cafeteria worker or other school-related professional, librarian, lifeguard, higher-ed professor, K-12 teacher or member of our retiree population, I want you to know how much you are valued and appreciated — both by the NYSUT organization and everyone at NYSUT Member Benefits.

Approximately 300,000 individuals (roughly half of the entire NYSUT membership) participate in one or more Member Benefits-endorsed voluntary or group program.

About 100,000 NYSUT members utilize our payroll or pension deduction options to pay for our endorsed programs, representing more than \$100 million in annual premium. Traffic to the Member Benefits website continues to increase with record numbers of visitors to the site year upon year.

NYSUT Member Benefits has been in existence since 1983 when the Member Benefits Trust was first created. In an effort to ensure that we continue to offer the highest-quality endorsed programs and services, I instructed Member Benefits to conduct focus groups of the NYSUT membership.

As a result, Member Benefits contracted with an independent market research firm earlier this year to hold both in-person and telephone focus groups of new and longtime members, school-related professionals, members of higher-ed and retirees.

Based on the feedback from these focus groups, we found that NYSUT members are looking for more options when it comes to insurance offerings, greater opportunities for everyday savings, more educational/enrichment opportunities, and are asking for a

New Endorsed Programs for NYSUT Members

Student Loan & Credit Card Debt Consolidation
The NYSUT Member Benefits Corporation is
pleased to announce the endorsement of Cambridge
Credit Counseling Corporation as a provider to
assist NYSUT members with better understanding
their student loan re-payment options and/or debt
consolidation.

NYSUT members are eligible to receive free, no-obligation debt and student loan consultations with one of Cambridge's certified counselors.

Additionally, a unique web portal is available on the Member Benefits website at a reduced rate to NYSUT members that can help explain the various options when paying down student debt, including student loan forgiveness programs, income-based repayment options and more. Regional workshops are expected to be held around the state to provide the necessary information for our members to make the best decision regarding their student debt.



Members that require more in-depth debt solutions, such as debt management and consolidation programs, will also receive a 10% discount on Cambridge's regular rates to help save even more.

Updates to Endorsed Programs

Term Life & Level Term Life Insurance Plan

As a result of their regular review process of all endorsed programs, the Trustees of the Member Benefits Trust voted to



name Metropolitan Life Insurance Company (MetLife) the new Plan Underwriter for our endorsed Voluntary Term Life & Level Term Life Insurance Plans as of March 1, 2018; these plans were previously underwritten by U.S. Life.

Coverage terms, benefit levels, beneficiary designations and rates for these programs have not been changed as a result of the Plan Underwriter change. Mercer Consumer remains the Plan Administrator for these programs.

There are approximately 74,100 certificates in force in the Term Life Plan representing almost \$27 million in annual premium. Meanwhile, there are approximately 3,100 certificates in force in the Level Term Life Plan representing almost \$1.4 million in annual premium.

Disability Insurance Plan

As a result of their regular review process of all endorsed programs, the Trustees of the Member Benefits Trust also voted to name Metropolitan



Life Insurance Company (MetLife) the new Plan Underwriter for our endorsed Disability Insurance Plan as of January 1, 2018; this plan was previously underwritten by Unimerica.

Coverage terms, benefit amounts and rates will not be changed as a result of the Plan Underwriter change. NYSUT in-service members and agency fee payers who are under age 65 and work 20 or more hours per week are eligible to apply for this program. Mercer Consumer remains the Plan Administrator for this program.

There are approximately 5,000 certificates in force in the Disability Plan representing more than \$2.8 million in annual premium.

Open Enrollment Update

Catastrophe Major Medical Plan

A limited-time, 45day open enrollment opportunity was held for the Catastrophe Major Medical (CMM) Plan from May 1 through June 15, 2017.



As a result, more than 17,000 new participants were added to the plan, effective January 1, 2018. There are now 68,000 total participants in the Plan representing approximately \$41 million in annual premium.

The CMM Plan underwent significant benefit changes as of Jan. 1, 2018. Once the annual deductible for this Plan has been satisfied, the Plan provides supplemental medical insurance coverage;

limited nursing/convalescent home benefits up to \$72 per day (\$80,000 lifetime maximum); and home health care benefits up to 25 hours per week (6,000 hour lifetime maximum benefit).

In addition, HealthSmart Benefit Solutions, Inc. is the new Administrator responsible for claims processing and coordination of appeals for benefit period effective dates of Jan. 1, 2018 and beyond; Mercer Consumer will continue to be responsible for claims processing and coordination of appeals for benefit period effective dates prior to that date.

Synchrony Bank Savings Program

As of March 16, 2018, there were approximately 6,400 accounts (money market, certificates of deposit and



high-yield savings accounts) representing \$337 million in deposits for this program. Synchrony Bank continues to offer some of today's most competitive interest rates on CD, money market and savings accounts.

NYSUT members must access the Synchrony Bank website via the Member Benefits site (enter code "Synchrony40" in the member code box) or mention that code when calling Synchrony Bank to receive preferred rates not available to the general public. Service to NYSUT Members

Member Benefits has a dedicated staff of 25 individuals located at both NYSUT Headquarters and



throughout New York State who pride themselves on their service – answering more than 57,000 phone calls and responding to more than 1,000 emails during 2017.

Staff attended or presented at approximately 300 meetings, workshops and conferences across the state. Meanwhile, approximately \$109 million in payroll- and pension-deducted premiums was processed by our staff this past year.
